GENERAL POLICY

Your privacy is a concern to Smart Carrier. Accordingly, Smart Carrier is setting forth below, its privacy policy for the use of data obtained by Smart Carrier from you through this website or emails sent by you to Smart Carrier.

NOTICE

If you only access Smart Carrier's website to read or download data from <http://www.smartcarrier.io> and <https://app.smartcarrier.io/register>, Smart Carrier collects and stores only the following information about you: the name of the domain from which you access the Internet (for example, aol.com, or dod.mil if you are connecting from a DoD's domain); the time and date you access our site; the full name of your computer or your IP address; the web pages you accessed; and the Internet address of the website from which you linked directly to Smart Carrier's site.
